**Subject:** **Discontinuation of CPT Code T1000 for Private Duty Nursing for Members 21 years old and older**

---

Per MDHHS CPT code chart updates, effective 7/1/23 CPT code T1000 for Private Duty Nursing (PDN) for members 21 years and older is retired and will no longer be used for this service. T1000 will still be utilized for Pediatric PDN and will be authorized directly through the already established process of providers seeking direct approval from MDHHS.

Beginning 7/1/23 please utilize bundled code S912x (which includes S9123 PDN: Registered Nurse and S9124 PDN: Licensed Practical Nurse) to authorize PDN for members 21 years and older. When billing under the bundled code providers will specify if they are billing for S9123 or S9124.

All authorizations utilizing the T1000 code have been early terminated and a new authorization using the new codes will need to be requested to cover Private Duty Nursing services. Any claims for T1000 for 7/1/23 or later will be adjudicated by DWIHN's finance department. Providers will need an authorization for S912x to file for the claims that were adjudicated for T1000 for 7/1/23 forward.

Any authorizations utilizing the individual codes S9123 and S9124 have also been early terminated and a new authorization using the bundled S912x code will be needed. The start date of the new auth should be the day following the early termination date of the previous auth.

Please note that 1 unit of T1000 was 15 minutes but 1 unit of S912x is 1 hour per unit.
