
STAFF ATTENDING VIA ZOOM:

CALLED TO ORDER: Meeting was called to order at 1:05pm

ROLL CALL: Roll call was taken by Arina Kartasheva, RRAC Liaison. A quorum was not present, this meeting was information only.

MOMENT OF SILENCE: Chairperson Ruth called for a moment of silence. A moment of silence was taken.

REVIEW AND APPROVAL OF AGENDA: Due to a lack of quorum, no official action regarding approving the agenda could be taken.

REVIEW AND APPROVAL OF MINUTES: Due to a lack of quorum, no official action regarding approving minutes from April 7th, 2025 could be taken.

ORR DIRECTOR'S REPORT: Dr. McCalister unofficially presented an informational report. She informed the committee of Senate Bill 271 of 2025, which is being considered by the Michigan Senate, and would allow fully virtual public meetings for public bodies. In addition, she updated the committee that Department ORR is working on their semi-annual report which is due June 30th, 2025. She discussed Department ORR meeting with "Top 5" Providers (i.e. providers that have the highest number of Recipient Rights complaints) and working with these providers to improve outcomes, reduce complaints, and build relationships. Dr. McCalister informed the committee that there are now three total drop-off boxes for individuals wishing to make Recipient Rights complaints in person and updated the committee regarding the number of providers and staff who have received Recipient Rights training. She also highlighted the accomplishments of individual investigators in the department. There were no questions.

RRAC CHAIRPERSON'S REPORT: Kenya Ruth expressed her pleasure at continuing to be part of the RRAC in her new position as chairperson. She complimented the leadership of the Office of Recipient Rights.

TRAINING: Nicole Williams presented a brief training on the full process involved with a Recipient Rights complaint, from initial report to complaint resolution. Kenya Ruth questioned the difference between a Recipient Rights complaint and an SUD complaint. Nicole Williams informed the committee that the two have similar investigations but are governed by two separate State of Michigan Health Codes.

NEW BUSINESS: Dr. McCalister and Chairperson Ruth had an individual discussion regarding the budget for the Office of Recipient Rights
