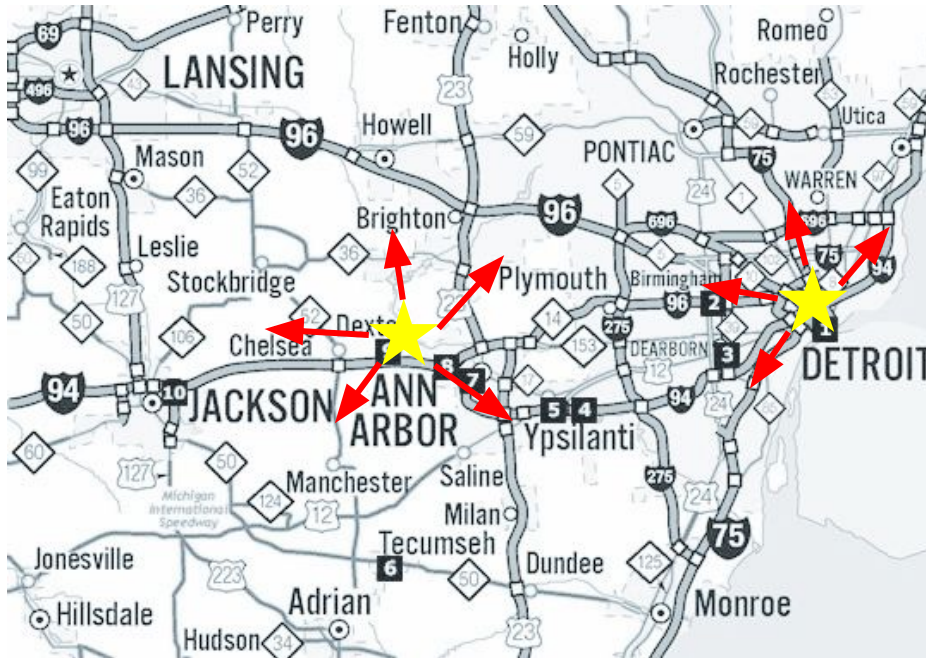

## WAYNE COUNTY IMPACT

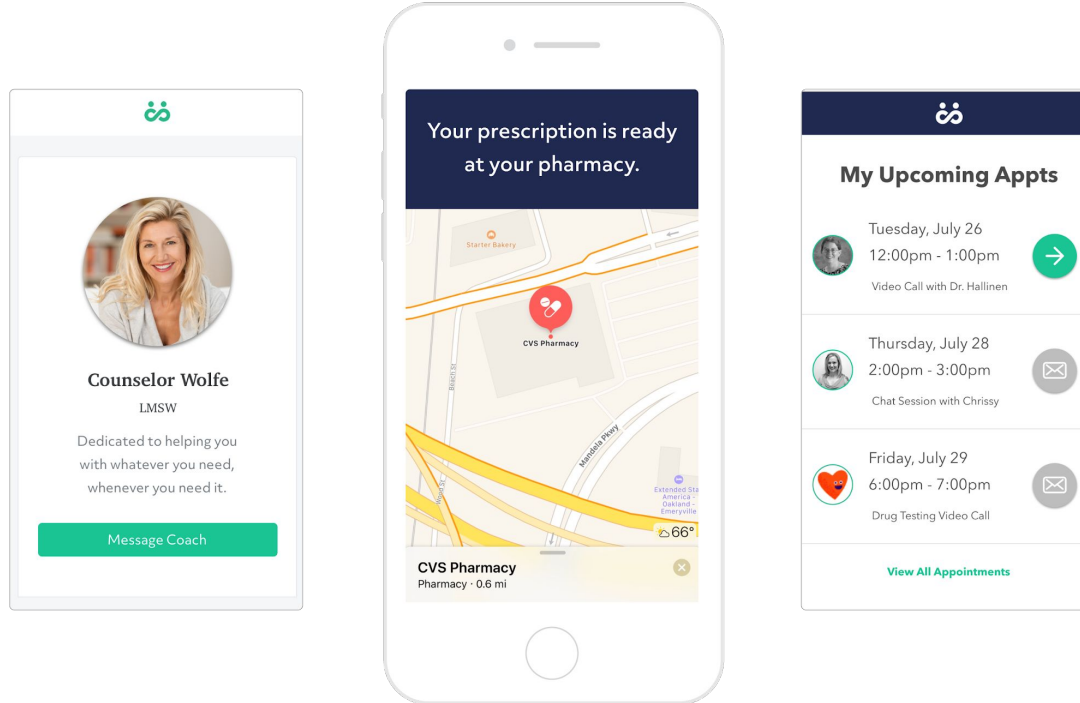


Workit Health has offices and FT employees in Wayne and Washtenaw Counties with telemedicine capabilities to serve across SE Michigan. We were the first telemedicine program to be licensed by LARA to provide addiction care.

Between January 2020 and April 2020, we saw a **257% ↑** in patients from Wayne County.

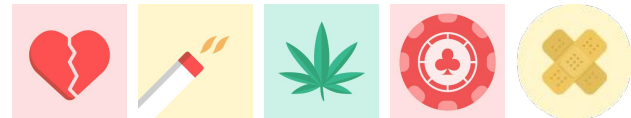

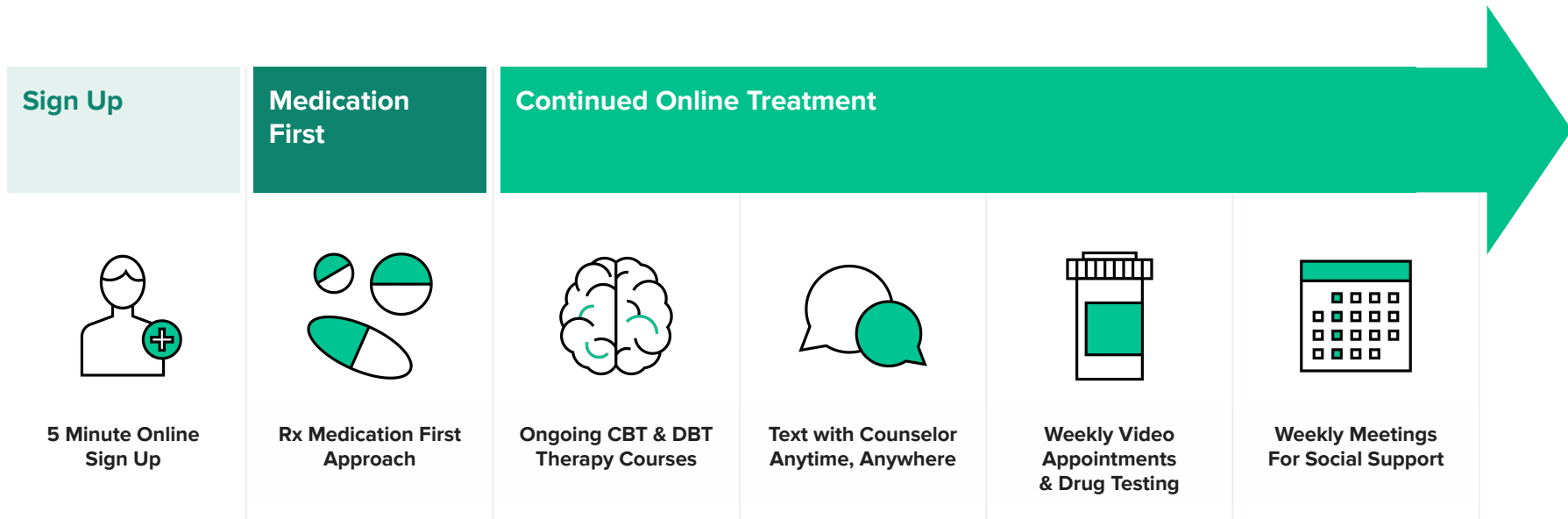


### Treatment

# Quantitative Shifts from COVID:

## **White Coat Syndrome:**

Patients are more comfortable connecting with providers and therefore display less anxiety in initiating treatment.

## **Appropriate Dosing:**

Improved reporting of initial substance use amount improves initial patient dosing

## **Increased Group Therapy**

**Engagement:** 40% increase in group attendance since COVID-19.

**Time to 1st Appt:** Time for patient scheduling their appointment to their appointment time has decreased by 42% since January 2020.

## **Increased Induction**

**Attendance:** 79% of people attended their 1st appointment with us.

## **Increased Demand:**

257% growth in patients from Wayne County between January 2020 and April 2020

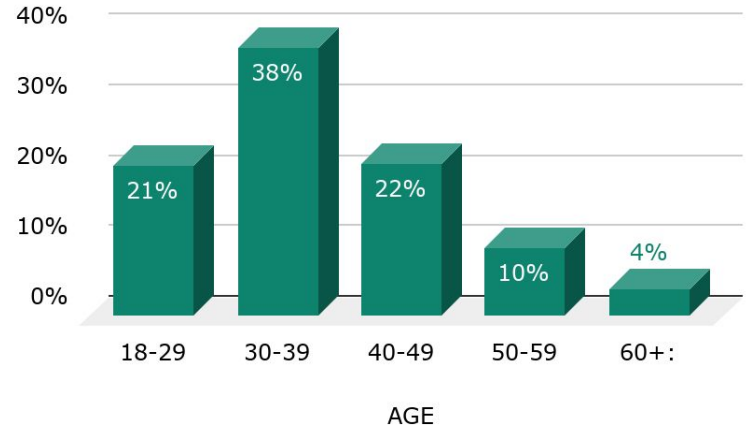
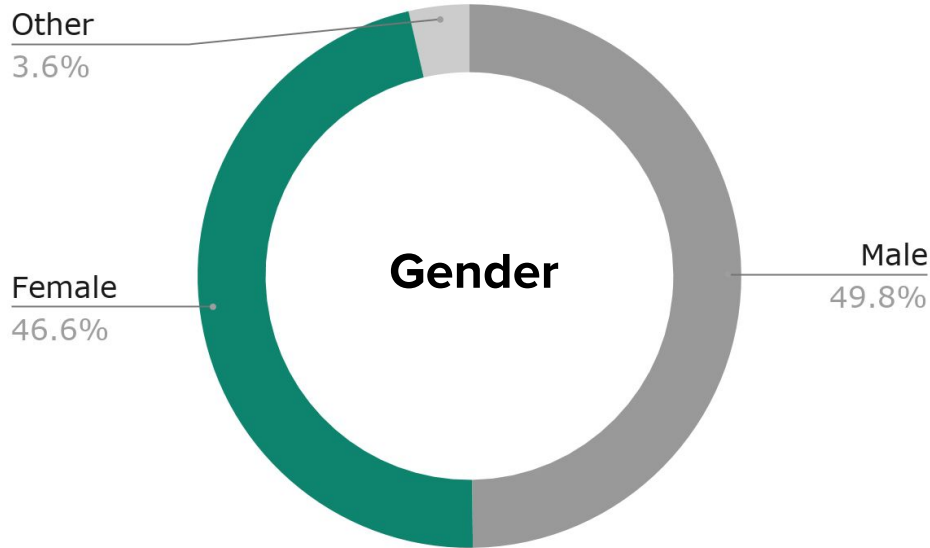

# MAT Patients: Demographics

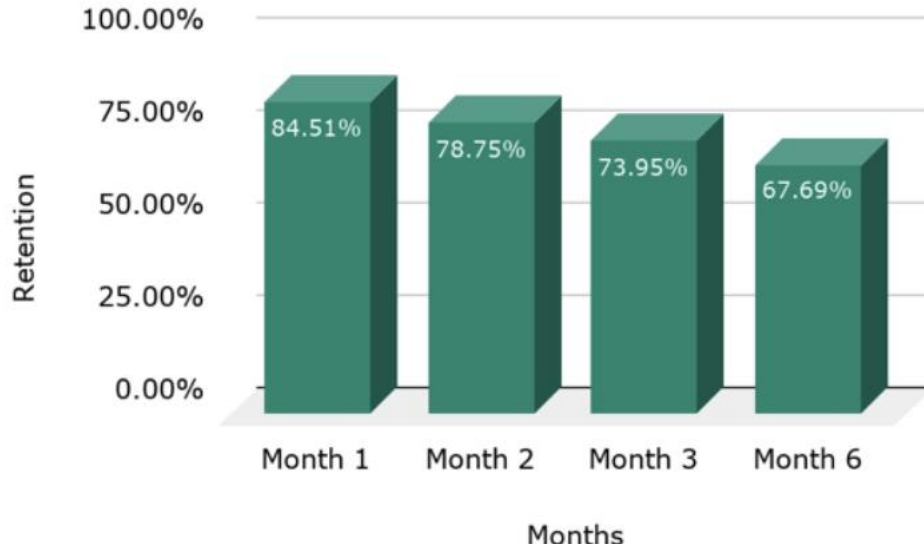


## Additional Insights

- **20.4%** of all clients are from ZIP codes that are classified as **rural**
- **42.5%** described some period of **housing instability** (homelessness, prison, staying on friends' couches, etc.), past or present.

## Retention Rate

First, we measure **retention**. We define retention by how many patients stay with us month over month.



### Retention

Workit Health defines retention as a continuous measure of patient's "length of stay," i.e. the length of time patients stay enrolled in the Workit Health MAT program month over month.

### Importance of Retention & Industry Standard

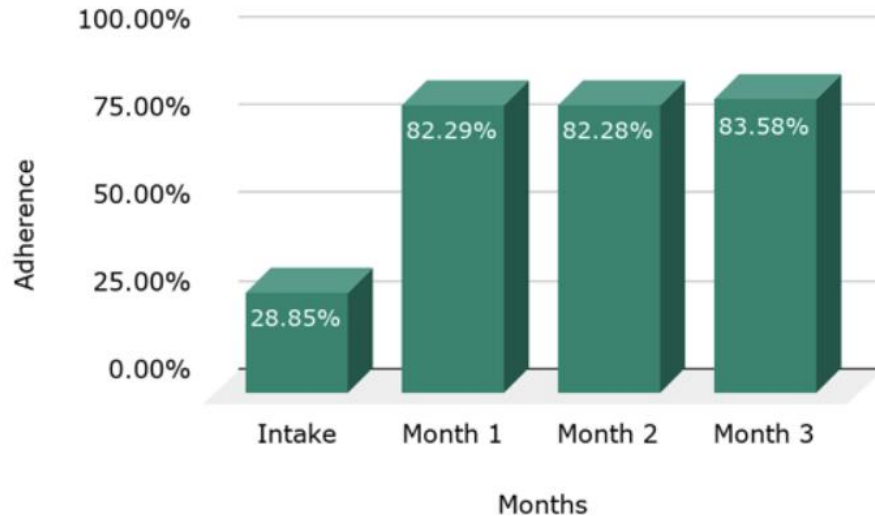
Longer substance abuse treatment episodes are usually related to positive outcomes, but as many as 50% of patients in drug and alcohol treatment drop out in the first month.

### Key Insights

- 84.51% of patients are still in the Workit Health program after four weeks.
- 67% of patients stay in the Workit Health program longer than 6 months.

## Adherence Rate

Adherence here is defined as clients who test positive only for prescribed medications and/or THC.



### Adherence

Adherence here is defined as clients who test positive only for medication and/or THC. Note this does not account for dropouts. An intent to treat analysis has been done and numbers are somewhat lower but still show majority are adherent.

### Key Insights

- Clients get adherent quickly and stay adherent.
- After at least 1 year, people test adherent 90.05% of the time.
- Patients' self-reports match drug tests 90% of the time.
