**VIII. New Business**

**A. Board Action 19-59 - Refreshments for Alcohol Tobacco and other Drugs (ATOD) Town Hall meetings**

The SUD Dept. is requesting \$1,000.00 in PA 2 funding to provide refreshments for town hall meetings throughout Wayne County. The ATOD town hall meetings will bring awareness and educate the communities we serve about the facts on ATOD. The town hall meetings will have experts in the field, doctors, legislators, providers and client testimonies.

**B. Board Action #19-60: SCRIPPS: Conquering Addiction (cont.)**

The SUD Department is requesting to continue with SCRIPPS Conquering Addiction series for an additional \$300,000 in PA 2 funding for 12 months, which is a multi-media campaign that was developed to bring awareness to the public on the most current issues around substance abuse and addiction in their communities. This campaign will cover a broad range of topics that are customized based on unique local addiction challenges, cultures, lifestyles and diversity in the market. The goal of Conquering Addiction is to bring awareness to the most current substance abuse issues, educate people on how to identify challenges within themselves and the people that surround them and direct people to the local help and resources that are available to them.

**C. Board Action #19-61: Michigan Department of Corrections (MDOC) Contract**

The SUD Department is requesting approval of this Board to contract with Michigan Department of Corrections (MDOC) for outpatient substance abuse treatment, and residential substance abuse treatment for parolees and probationer (offenders) under the jurisdiction of the Michigan Department of Corrections (MDOC). DWMHA will provide SUD Treatment Network Providers and administrative services. The contract is effective November 1, 2018, however, SUD Treatment Services will begin April 1, 2019 (Implementation Date) utilizing our current SUD providers. MDOC will not contract directly with providers as of March 31, 2019. Services delivered will be evidenced based, gender specific, trauma informed care designed to address the substance abuse and criminal behavioral problems. Currently, MDOC is planning to pay the PIHPs a 12% administrative rate based on service cost. MDOC will also be advancing 6 months of estimated administrative costs and three months of estimated service costs prior to the Implementation Date.
