SUBJECT: Third Judicial Circuit Court, Clinic for Child Study

PROVISION OF SERVICE AFFECTED: Targeted Case Management – Treatment Planning

APPROVED CODES: T1017-TP

REVISION SUMMARY

The initial version of this bulletin listed H0031-3C as the reporting code for assessment of Competency and Criminality. Code 96101-3C was preferred by the Clinic for Child Study for reporting assessment of Competency and Criminality. We have removed H0031-3C and replaced it with code 96101-3C.

GUIDANCE USAGE

This bulletin is applicable exclusively to the Third Judicial Circuit Court, Clinic for Child Study. The procedure code for Targeted Case Management services has been modified to include a local modifier (TP) to discriminate between treatment planning activities (T1017-TP) and other typical case management activities (T1017). This local modifier may only be used when reporting services provided to children through a direct contract with DWMHA for Outpatient Mental Health Services. (See complete list of the Approved Codes and Modifiers for the Third Circuit Court, Clinic for Child Study, below.)

BACKGROUND

Per the Michigan Department of Health and Human Service's "PIHP/CMHSP Reporting Cost Per Code and Code Chart" revised on 04/01/2018, page 51 states, "Treatment Planning...-Case manager or supports coordinator do not report treatment planning, as this is part of Targeted Case Management and Supports Coordination." Other professional staff and independent facilitators report treatment planning with procedure code H0032, but case managers do not. Case managers report treatment planning as part of their typical activities, with procedure code T1017.

The DWMHA wishes to collect more detailed information regarding the provision of Targeted Case Management services at the Third Judicial Circuit Court, Clinic for Child Study. The DWMHA is specifically

interested in the proportion of case management activities related to treatment planning activities versus other typical case management activities. Therefore, treatment planning activities provided by a case manager will now be reported as procedure code T1017-TP.

Per the Michigan Medicaid Manual, Targeted Case Management services include: Assessment, planning, linkage, advocacy, coordination, and monitoring. Per the Michigan Department of Health and Human Service's "PIHP/CMHSP Reporting Cost Per Code and Code Chart" revised on 04/01/2018, page 47 states, "Targeted Case Management...-Includes case manager's activities of pre-planning, treatment planning, [and] periodic review of plan".
