# BACKGROUND

Starting January 1, 2020, under the Calendar Year (CY) 2020 Physician Fee Schedule <u>final rule</u>, the Centers for Medicare & Medicaid Services (CMS) will pay Opioid Treatment Programs (OTPs) through bundled payments for opioid use disorder (OUD) treatment services in an episode of care provided to people with Medicare Part B (Medical Insurance).

Under the new OTP benefit, Medicare covers:

- U.S. Food and Drug Administration (FDA)-approved opioid agonist and antagonist medication assisted treatment (MAT) medications
- Dispensing and administration of MAT medications (if applicable)
- Substance use counseling
- Individual and group therapy
- Toxicology testing
- Intake activities
- Periodic assessments

## PROCEDURE

# Fee Schedules

DWIHN has added the below CMS-approved procedure codes in the MH-WIN information system for persons with MI Health Link insurance seeking OTP services. These new fee schedules were added to the SUD provider's "Dual Eligible" contract record. The codes and rates for OPT services for members with Medicaid-only insurance remain unchanged in the "Substance Use Disorder Treatment" contract record.

## **AUTHORIZATIONS**

OTP services will continue to require prior authorization for persons with Medicaid-only insurance and MI Health Link insurance. The below listed codes will be utilized for persons with MI Health Link insurance. The codes authorized for OTP services for persons with Medicaid-only insurance remain unchanged. DWIHN will not provide authorization for OTP services for persons with Medicare insurance.

## <u>CLAIMS</u>

The process to submit claims for OTP services for persons with Medicaid-only insurance or MI Health Link insurance remains the same. Claims for OTP services for persons with Medicare should NOT be submitted to DWIHN and rather should be submitted to Medicare for reimbursement.

## CREDENTIALS

Clinicians providing SUD services to members with MI Health Link insurance must meet Medicare credentialing requirements. Clinicians providing SUD services to members with Medicaid-only insurance must meet Medicaid credentialing requirements.
