GUIDANCE USAGE

This bulletin is applicable exclusively to those SUD Providers rendering services funded by the State Target Response Block Grant for SUD. DWMHA has determined four local modifiers for this program in order to differentiate between the four clinical programs funded by this block grant.

BACKGROUND

Use of these four modifiers is limited to those providers that are participating in the SUD State Target Response Block Grant. These modifiers are further limited to those services that the SUD providers are authorized to render. The specific informational modifiers listed below do not need to be specified on the authorization request; but they must be added to the claim when submitted by the provider.

Program	Modifiers	Brief Description (See "State Targeted Response Block Grant" document issued by DWMHA for more detailed descriptions.)
Opioid Overdose	Z1	For individuals diagnosed with an opioid overdose or a substance use disorder.
Innovative Strategies for Pregnant Women	Z2	For Women who are diagnosed with a substance use disorder and/or who are postpartum.
Drug Court Recovery Support	Ζ3	For individuals under the authority of the Wayne County Drug Court System who have received a court admission screening, substance use diagnosis, treatment as jail alternative, engaged with PRC.
Mission Rep-Jail	Z4	For individuals receiving SUD treatment under Michigan Department of Correction with Women Huron Valley or the Detroit Reentry Center. Opioid and case management services.
