GUIDANCE USAGE

This bulletin is applicable exclusively to the Third Judicial Circuit Court, Clinic for Child Study. Third Judicial Circuit Court, Clinic for Child Study will no longer deliver the full array of services as a Children's Outpatient Provider but instead will provide limited services. The following provision of services are approved for use: Alcohol and/or Drug Assessment via the GAINS Assessment, Assessment, by non-Physicians, Group Psychotherapy, and Psychological Testing.

BACKGROUND

For over the past ten (10) years, the Third Judicial Circuit Court, Clinic for Child Study has been a service provider for Outpatient Services to children, youth and their families who are involved or are at-risk of being involved in the Juvenile Justice System. The type of relationship between Detroit Wayne Integrated Health Network (DWIHN) has been valuable over the years; however, in order to maintain sustainability, the Clinic for Child Study determined system transformation was needed. After a year-long strategic plan was conducted by the Third Circuit Court, Wayne County, and the Clinic for Child Study in collaboration with DWIHN, "The New Clinic and Juvenile Justice Model," was created. The model aims to provide the following: 1.) an early assessment, 2.) guidance and assurance families receive needed mental health services and community resources, 3.) divert more youth to alternative solutions, and 4.) reduce recidivism/youth advancing to the adult system.

AUTHORIZATION PROCESS

The Third Circuit Court, Clinic for Child Study will no longer be identified as a Clinically Responsible Service Provider (CRSP); therefore, they will no longer be the holder of the Individual Plan of Service (IPOS) for the youth involved in services. Therefore, a specific authorization process has been created in order to

serve this population in an efficient manner (NOTE: retro-authorization will be given for services rendered between June 8th 2020 – September 30th 2020, as needed. Thereafter, timely submission is required).

- If a youth enters Third Circuit Court, Clinic for Child Study for an assessment and has a CRSP, then the CRSP remains in place.
- If a youth enters Third Circuit Court, Clinic for Child Study for an assessment only and does not have a CRSP then they will be assigned to DWIHN as the CRSP as long as no other services are deemed necessary.
- If a youth enters Third Circuit Court, Clinic for Child Study for an assessment and continues on for Sexual Awareness Information and Treatment (SAIT) services, a CRSP must be assigned if not already identified.

Authorization Process

- 1. The Third Circuit Court, Clinic for Child Study identifies an adjudicated youth that needs an Assessment and/or SAIT services.
- 2. The court contacts DWIHN's Access Center to verify eligibility and enroll the youth if not currently enrolled with DWIHN.
- 3. If the youth is eligible, the Access Center completes the enrollment, assigns a CRSP, and creates an intake appointment.
- 4. If the family/youth declines additional services with a CRSP, DWIHN will be assigned by the Access Center as a CRSP. An appointment will be made in the Care Coordination Calendar to allow for enrollment completion. Third Circuit Court, Clinic for Child Study should use MH-WIN's consumer module, and then go into the consumer chart and enter the authorization request. Specifically, authorizations for the Social History/biopsychosocial and assessments. All SAIT authorizations must be entered by the CRSP (SAIT is currently 21 weeks). NOTE: this is the sole method for submitting authorization requests. Emailed request will no longer be accepted.
- 5. UM Staff will respond within 72 hours of receipt of request. NOTE: if there are any issues, please email UM staff at <u>pihpauthorizations@dwihn.org</u>.
- 6. A Notification email is sent to Third Circuit Court, Clinic for Child Study staff after the authorization is entered into MHWIN.
- 7. Once the service is completed the assessment/documentation should be uploaded or HIE into the consumer's chart in MHWIN
 - MHWIN.com
 - Consumer chart
 - Enter consumer information
 - Uploaded and scanned documentation Supporting documentation for SAIT (i.e., clinical documentation that is being completed that supports the service provided)
 - Select "Third Circuit Court" as document type
 - Attach document and click upload
- 8. In addition to uploading the above-named documentation, the biopsychosocial will need to be completed and be uploaded or HIE into the consumer's chart MH-WIN.
- 9. If further services are necessary and the youth is without a CRSP (other than DWIHN) they will be referred back to the Access Center to identify a CRSP within the provider network for follow up.
- 10. Third Circuit Court, Clinic for Child Study will also notify Care Management Organizations (CMO a.k.a Probation Officer) to coordinate follow up care with the youth and Community Mental Health.
