SUBJECT: Use of new "Bundled Authorization Only" codes for

unlicensed residential community living support services.

SERVICE AFFECTED: Unlicensed residential community living support

services, billed as H2015 or T2027.

BACKGROUND

MDHHS retired the use of H0043 (per diem) for community living support services in an unlicensed residential setting, effective 09-30-2020. On 10-01-2020 MDHHS implemented five "Ux" modifiers to indicate the number of members in a shared living arrangement. Concurrently, DWIHN implemented five "Sx" modifiers to indicate the number of staff who are serving the members simultaneously. These new "Ux" and "Sx" modifiers are used with procedure codes H2015 and T2027.

In order to ease the burden of the transition from H0043 to H2015 and the use of the new modifiers, DWIHN temporarily suspended the authorization requirement to submit claims for procedure codes H2015 and T2027. DWIHN will reinstate the authorization requirement to submit claims for procedure codes H2015 and T2027, effective 06-01-2021.

PROCEDURE

DWIHN has deployed two new "Bundled Authorization Only" codes which are used to make authorizations for H2015 and T2027 procedure codes.

Billing providers should <u>not</u> submit the "Bundled Authorization Only" codes when submitting claims. Claims must be submitted with the billing codes H2015-Ux-Sx-Xx or T2027-Ux-Sx-Xx (Note: Ux, Sx and Xx represent the clinically appropriate modifiers).
