



Signing Your Contract

Overview: Using our new CobbleStone contract management system, DWIHN providers and other external parties can now obtain and electronically sign agreements easier and faster than ever before. This document guides you through the steps.

1. After DWIHN creates the contract they will email it out for signature to the email address of the designated signer for the provider organization. The email will read "DWIHN CobbleStone Alerts, Invitation to sign your document":



2. When you open your email, the message will identify the DWIHN sender, the company being asked to sign, and the contract title. At the bottom will be a link labelled "Sign Document(s)". Click this link to review and sign the document.

- Your Signature Processing dashboard should appear after clicking the link in the email. The main section shows your contract. In the left panel, you will see a section titled "What to do Next". This section provides links to the pages requiring signature. Once you are comfortable with the contract, use the link(s) to find your signature box. To read the contract, you can use the [Download] button on the right side to download it to your computer, or you can scroll through it using the Next button above the document.

- Upon selecting the Signature link, you will be transferred to the signature page. The signature page provides a "Sign Here" box showing you where to sign.

5. Select the "Sign Here" box to sign the contract. You can draw your signature with your mouse by using the "Draw Signature" option, or type your signature using the "Type Signature" option.

6. Once you sign the document for each area where your signature is required, links will appear at the top and bottom of the screen to [Verify and Complete] the signature process. Click the link. ***Please note*** you must click the **[Verify and Complete]** button after you've signed the document to complete the signature process.

 All Files have been Signed! - Click "Verify and Complete" if you are done.

7. Finally, you must select the **[Complete]** box to finish the signature process.
