**SUBJECT:** Use of new modifier “U7”

**SERVICE AFFECTED:** All services funded through a Self-Directed arrangement (i.e., Self-Determination)

### **BACKGROUND**

Historically, services funded through a self-directed arrangement were reported to MDHHS with the same codes and modifiers as services funded through traditional funding arrangements (i.e., fee-for-service claims submission or per-member-per-month payments). Effective 10/01/2020, MDHHS requires the submission of a new modifier, “U7”, with a select list of procedure codes which an individual may choose to be funded through a self-directed arrangement. Only services with an executed written agreement are considered a self-directed arrangement.

### **PROCEDURE**

DWIHN has added the “U7” modifier to the MH-WIN system as an “Informational” modifier that billing providers add when submitting claims/encounters. The “U7” modifier does not affect the rate for the service. The select list of codes which must be reported with the “U7” modifier are listed in the chart below.

**CHART: Codes reported with U7 Modifier if the individual has a self-directed arrangement for this service**
