# **CALL TO ORDER:**

Ms. Kenya Ruth (Chairperson) welcomed everyone to the meeting. The meeting was called to order at 1:20pm by Ms. Ruth.

# **REVIEW AND APPROVAL OF MINUTES:**

The Chairperson called for a motion on the meeting minutes from September 12, 2022. Commissioner Kinloch motioned to approve minutes with any necessary corrections. Janet Harmon supported the motion.

# RRAC CHAIRPERSON'S REPORT:

Chairperson Kenya Ruth gave a verbal report. She discussed removing the stigma on mental health. She also stated as a third generation U.A.W. she takes fighting for the rights of others very seriously.

**Reporting:** We are preparing for our annual report which captures data for October 1, 2021 to 9/30/2222.

**The RRAC committee** is required by the State of Michigan to make four recommendations and outcomes for the ORR department and we established the following:

Currently our committee is working on developing four new outcomes and recommendations. We are requesting all providers ensure their employees are trained within 30 days of their hire to remain in compliance of the Mental Health Code Citation MHC 1755(5)(f), Standard 3.3.1. Moving forward we will impose the \$50.00 fee for failing to train their staff within 30 days of hire.

The ORR department also accepts SUD complaints and we continue to work with the Substance Use Disorder (SUD). When the ORR receives a complaint involving a substance abuse center we forward it to SUD for processing, if you have an allegation please call 313 344-9099 ext. 3112 (Judy Davis).

The RRAC requested training for The ORR staff and RRAC.

To close investigations under 75 days.

Evaluate the current work processes to increase our work flow processes.

To ensure RRAC receive trainings to make informed decisions

Receive information on cases to make a more informed decision about appeals

# **ORR-Overall Allegations:**

For the office of Recipient Rights

The ORR Annual Reporting data received FY 21-22 we received 1,634 allegations, we investigated 1288 cases, and substantiated 364 investigations.

The ORR received allegations from 450 recipients and 540 employees which represents the highest number of individuals that filed complaints.

This is significant and supports the fact that recipients and employees are one of our greater resources in protecting the rights of the ones we serve.

The Office of Recipient Rights also oversees the training for all DWIHN and provider employees,

FY 21-22, the Recipient Rights Trainers registered 5360 participants, 2807 attended and passed the virtual class, and there were 2553 no shows.

**Before we move to new business if this body could vote to accept my report.** The Director's report was accepted by the committee.
