**SUBJECT:** H2025 - Job Coaching

**SERVICE AFFECTED:** Supported Employment – Job Coaching

### **BACKGROUND**

Historically MHDDS required code H2023 to report Supported Employment services, including Job Coaching. Effective 01-01-2023, MDHHS will require the reporting of procedure code H2025 for Supported Employment-Job Coaching services; the remaining Supported Employment services will continue to be reported as H2023.

### **PROCEDURE**

In efforts to be following Michigan Department of Health and Human Services, (MDHHS) coding expectations, effective 1/1/2023 the procedure code H2025 must be reported for Supported Employment-Job Coaching services. Job Coaching is for individual competitive integrated employment and includes identifying, through job analysis, and providing services and supports that assist the individual in maintaining employment.

### **AUTHORIZATIONS**

Authorization requests for “Supported Employment – Job Coaching” must use the “Authorization Only” code H2025 with no modifier.

### **CLAIMS**

Claims for “Supported Employment – Job Coaching” must be submitted with the MDHHS required education-level modifier “HM” for Less than Bachelor’s Degree, which is prefilled on the fee schedule in the contract record. The informational modifiers “Y4” for SAMSHA approved EBP for Co-Occurring disorders; and “HH” for Integrated Mental Health and Substance Abuse are not prefilled and can be added to the claim, if appropriate.
