BACKGROUND

Effective 12/31/2022, 99318 code was retired by CMS. DWIHN will utilize T2011 with the "AN" modifier to report Annual Resident Review services. The T2011 (without the "AN" modifier) will continue to be utilized for the Pre-Admission Screening.

The "MI" and "ID" modifiers will continue to be used to identify the population receiving the services.

The "IC" modifier will continue to be used for "Incomplete Assessments".

AUTHORIZATIONS

Prior authorization is not required for these services.
