SUBJECT: Psychological Testing for Guardianship Hearings

SERVICE AFFECTED: 96130 DG / 96131 DG

BACKGROUND:

Clinically Responsible Service Providers (CRSPs) can complete Psychological Testing for members prior to their Guardianship hearing, for the purpose of testifying.

PROCEDURE:

Effective 10/01/2024, Psychological Testing services for Guardianship Hearings in probate court can be billed with procedure codes 96130-DG and 96131-DG.

AUTHORIZATION / CLAIMS:

96130-DG and 96131-DG requires prior authorization. Request 9613x "Bundle Authorization Code" to authorize 96130-DG and 96131-DG. When submitting claims ensure that the code, appropriate modifiers, and the staff credentialing modifiers are submitted. Refer to the Reference section below for additional information.

CODE CHART:

Service	CPT Code	Type
Psychological Testing	96130 DG	First 60 minutes <i>Max Amount = 1 per day</i>
Psychological Testing	96131 DG	Each additional 60 minutes <i>Max Amount = 7 per day</i>
