**SUBJECT:** Private Duty Nursing services

**SERVICE AFFECTED:** T1000 – Private Duty Nursing; Retired 07-01-2023.  
S9123 & S9124 – Private Duty Nursing.

### **BACKGROUND**

Historically, MDHHS allowed the usage of T1000 for Private Duty Nursing services, 15-minute unit, rendered by both Registered Nurses and Licensed Practical Nurses, for members with a HAB Waiver. On 07-01-2023, MDHHS discontinued procedure code T1000.

MDHHS continues to allow the usage of S9123-TD and S9124-TE for Private Duty Nursing services, Hour unit, rendered by either Registered Nurse or Licensed Practical Nurse, respectively.

### **PROCEDURE**

DWIHN has early terminated authorizations for T1000 Private Duty Nursing service and expired all T1000 fee schedules. New authorizations will need to be made for the S9123 & S9124 - Private Duty Nursing service codes to replace the T1000 authorizations that were terminated.

DWIHN has deployed a new “Bundled Authorization only” code, **S912X**, to authorize both S9123 and S9124 services. This new bundled authorization will be used for all Private Duty Nursing authorizations effective from 07-01-2023 and forward.

### **BILLING**

The provider will submit claims for either S9123 or S9124 with one of the required “MDHHS Staff-Credential” modifiers plus the appropriate “Member Modifier”, and any “Allowable” modifier as needed. See charts below for billing codes and modifiers. Claims will not pay for the “Bundled Authorization only” code S912X.
