### BACKGROUND:

Historically, the H0004 and H0005 codes were used only in the Substance Use Disorder line of business. Effective April 1<sup>st</sup> 2025, these codes were added to the Mental Health line of business per the updated chart released by MDHHS on April 4 2025.

### PROCEDURE:

These codes may only be used with members who have a co-occurring/dual MH and SUD diagnosis. They are included in the CCBHC program. These codes will be added to the MH Adult Outpatient contract records.

### AUTHORIZATION / CLAIMS:

These claims must be reported with the HH modifier (Dual diagnosis MH plus SUD) with Staff Credential modifiers. For the H0005 procedure code, you must also add the multiple member modifiers.

### CODE CHART:

Code & Description	Modifiers	Notes/Comments
H0004 Behavioral Health Counseling	HH plus Credentialing modifier	(15-minute code)
H0005 Substance Use Disorder Outpatient Care	HH plus Credentialing modifier and multiple member modifiers	(Encounter)
