SUBJECT:	Screening for Depression	
SERVICE AFFECTED:	G8431 / G8510 – MH Adult Outpatient, MH Child Outpatient and DD Outpatient	

BACKGROUND:

Historically there are instances when the Clinically Responsive Service Providers (CRSPs) complete Depression Screenings. Effective 4/1/2025 Michigan Department of Health and Human Services (MDHHS) issued further instructions. Procedure code G8431 will be used to report a positive screening result and procedure code G8510 will be used to report a negative screening result. Both procedure codes are "informational only" codes and do not pay a significant rate.

PROCEDURE:

Effective 4/1/2025, Clinically Responsive Service Providers (CRSPs) will use informational CPT code(s) G8431 and G8510 to report Depression Screenings performed in conjunction with completing an assessment. Refer to the following formerly published bulletins for the assessment codes:

AUTHORIZATION / CLAIMS:

Procedure Codes G8431 and G8510 do not require prior authorization or staff credentialing modifiers. Claims for G8431 and G8510 must be submitted on the same claim as the assessment's procedure code(s). Claims for G8431 and G8510 may overlap the date and time reported for the assessment's claims.

CODE CHART:

Service	CPT Code	Туре
Depression Screening (Positive Result)	G8431	This code is used to report a positive depression screening result where a follow-up plan has been documented. This code is typically used in conjunction of administering
		assessments. This is an informational code only.
Depression Screening (Negative Result)	G8510	This code is used when a healthcare professional performs a screening for depression and the patient is found to have a negative result, meaning they do not show signs of depression. In this case, no further follow-up is necessary. This is an informational code only.
